Notifying goods in Leather, Footwear and Accessories sector in  
furtherance of the Order**

The Government of India has issued Public Procurement (Preference to Make in India), Order 2017, vide the Department of Industrial Policy and Promotion (DIPP) Notification No. P45021/2/2017 –B.E.–II dated 15.06.2017 to encourage 'Make in India' and promote manufacturing and production of goods and services in India with a view to enhancing income and employment.

2. Subject to provisions of Public Procurement (Preference to Make in India), Order 2017, notified vide reference cited above, and in furtherance of this order, the following types of products in Leather, Footwear and Accessories Sector, where sufficient domestic manufacturing capacity and local competition is available, the minimum local content is specified as below:
