Sub: Release of an amount of Rs. 26,72,40,900/- (Rupees Twenty Six crore Seventy Two lakh Forty thousand Nine Hundred only) as Central Capital Investment Incentive for access to credit (CCIAC) Subsidy during the year, 2021-22 in favour of HPSIDC.

The undersigned is directed to convey sanction of the President to the release of an amount of Rs. 26,72,40,900/- (Rupees Twenty Six crore Seventy Two lakh Forty thousand Nine Hundred only) for payment of Central Capital Investment Incentive for access to credit (CCIAC) under Industrial Development Scheme (IDS) 2017 for the financial year 2021-22 in respect of 21 beneficiary units of Himachal Pradesh (as per list enclosed at Annexure), on the basis of recommendations of the State Level Committee concerned and as per existing terms and conditions of the scheme.

2. As per the Notification No.2(2)/2018-SPS dated 23rd April,2018, HPSIDC has been notified as the nodal agency for disbursement of central incentives in the state of Himachal Pradesh under IDS 2017.

3. This being the first release under Central Capital Investment Incentive for access to credit (CCIAC) under IDS 2017 for the State of Himachal Pradesh, as such no Utilization Certificate under this scheme is due from HPSIDC.

4. The sanctioned amount may be released in favour of The Himachal Pradesh State Industrial Development Corporation Ltd. (HPSIDC) in to their Account No 15550210001813, UCO Bank, IFSC Code UCBA0001555, Address UCO Bank, New Himrus Building, Circular Road, Near Himland Hotel Shimla.-171001.

5. The due date for submission of UC in respect of this release is within twelve months of the closure of the financial year.

8. Release of the above mentioned amount to HPSIDC is subject to the following terms and conditions:


- (i) HPSIDC will maintain a separate account of the funds released by this Department towards "Central Capital Investment Incentive for access to credit (CCIIAC) under Industrial Development Scheme (IDS) 2017" for disbursement of subsidy to the beneficiary units as per details enclosed.
- (ii) HPSIDC shall verify each & every claim before disbursement and shall disburse the incentive to the eligible units immediately on receipt funds from DPIIT.
- (iii) The disbursement made by HPSIDC from the Grant shall be open to inspection and audit by the sanctioning authority.
- (iv) After disbursement of incentive for the purpose for which it has been sanctioned, HPSIDC, shall submit to the Department for Promotion of Industry & Internal Trade, New Delhi the Utilization certificate within twelve months of the closure of the financial year as per GFR and no further funds will be released unless the entire amount previously released is fully utilized and utilization certificates are furnished. The Utilization Certificate will be signed by the Managing Director, HPSIDC.
- (v) A quarterly statement of the subsidies disbursed indicating also the names of the beneficiaries, the amount of subsidy released to each unit, the date of their application, the date of approval of the SLC, the date of disbursement of subsidy etc, shall be furnished by HPSIDC to this Department by the 10th day of the month following the end of each quarter.
- (vi) HPSIDC would devise a suitable mechanism to ensure adequate transparency and fairness in the disbursement of subsidy. HPSIDC shall furnish an undertaking that they have been following the provision of Rule-4 (I)(a) and (b) of RTI Act, 2005.
- (vii) HPSIDC would furnish a performance-cum-achievement report at the end of each financial year highlighting the number of units set up in the State, investment made and the employment generated etc., and the quantitative vis-a-vis qualitative outcome achieved out of Central Capital Investment Subsidy Scheme including suggestions/policy reform initiatives for further refinement of the Scheme.
