Sub: Release of an amount of Rs. 5,74,97,955/- (Rupees Five crore Seventy Four lakh Ninety Seven thousand Nine Hundred Fifty Five only) as Central Capital Investment Subsidy during the year, 2019-20 to the 28 beneficiary units located in the State of Himachal Pradesh.

Sir,


The undersigned is directed to convey sanction of the President to the release of an amount of Rs. 5,74,97,955/- (Rupees Five crore Seventy Four lakh Ninety Seven thousand Nine Hundred Fifty Five only) for payment of Central Capital Investment Subsidy during the financial year 2019-20 in respect of 28 beneficiary units of Himachal Pradesh (as per list enclosed at **Annexure**), on the basis of recommendations of the State Level Committee concerned and as per existing terms and conditions of the scheme.

2. As per the Notification No.4(1)/2003-SPS dated 6<sup>th</sup> March, 2003, HPSIDC has been notified as the nodal agency for routing the disbursal of subsidies/incentives under various schemes provided in the New Industrial Policy issued by DPIIT (earlier) on 7<sup>th</sup> January, 2003 for the State of Himachal Pradesh.

3. Vide letter No. HPSIDC/IFD-121-A-IV 4340 dated 01.10.2019, HPSIDC has reported that a sum of Rs. 1.55 crore remains unspent as on 30.09.2019 and is lying with HPSIDC under Central Capital Investment Subsidy Scheme. The unspent amount of Rs. 1.55 crore includes Rs. 17,00,000/- (Rs. Seventeen Lakh only) which should have been disbursed till 31<sup>st</sup> March, 2018. Since the amount of Rs. 17 lakhs has been with HPSIDC for more than a year and has not been utilized, this has been taken into account in the present sanction. **The said amount (Rs. 17 lakhs) may be utilized for this sanction. This release is made by deducting an amount of Rs. 17,00,000/- from the total amount of Rs. 59197955/-.**

The sanctioned amount may be released in favour of The Himachal Pradesh State Industrial Development Corporation Ltd.(HPSIDC) to their Shimla Bank Account No.15550200010024, United Commercial Bank(UCO), HPMIDC Branch, New Himrus Building, Cart Road, Shimla, MICR Code 171028004. IFSC/RTGS Code UCBA0001555.

The due date for submission of UC in respect of this payment is by 31.03.2021.

6. The Total release under this object head, including the present sanction would be Rs. 87,67,84,270/- during the current financial year as against the budget provision of Rs. 132.96 crore for the financial year 2019-20.

7. The expenditure is debitable to the following Head of Account:-

- 2885- Other Outlay on Industries & Minerals (Major Head)
  - 02- Development of Backward Areas (Sub Major Head)
  - 02.101- Subsidies (Minor Head)
  - 15.05 - Package for Special Category States for J&K Himachal Pradesh and Uttarakhand
  - 15.05.33 Subsidies
- Under Demand No.12 for the year, 2019-20.

8. Release of the above mentioned amount to HPSIDC is subject to the following terms and conditions:

- (i) HPSIDC will maintain a separate account of the funds released by this Department towards "Central Capital Investment Subsidy" for disbursement of subsidy to the beneficiary units as per details enclosed.
- (ii) HPSIDC will scrutinize the claims before disbursement of subsidy and subsidy should be disbursed to the eligible units within 7 days of release of funds by DPIIT.
- (iii) The disbursement made by HPSIDC from the Grant shall be open to inspection and audit by the sanctioning authority.
- (iv) After disbursement of subsidy for the purpose for which it has been sanctioned, HPSIDC, will submit to the Department for Promotion of Industry & Internal Trade, New Delhi as per GFR-2017 the Utilization certificate within twelve months of the closure of the financial year and no further funds will be released unless the entire amount previously released is fully utilized and utilization certificates are furnished. The Utilization Certificate will be signed by the Managing Director, HPSIDC.
- (v) A quarterly statement of the subsidies disbursed indicating also the names of the beneficiaries, the amount of subsidy released to each unit, the date of their application, the date of approval of the SLC, the date of disbursement of subsidy etc, shall be furnished by HPSIDC to this Department by the 10<sup>th</sup> day of the month following the end of each quarter.
- (vi) HPSIDC would devise a suitable mechanism to ensure adequate transparency and fairness in the disbursement of subsidy. HPSIDC shall furnish an undertaking that they have been following the provision of Rule-4 (I)(a) and (b) of RTI Act, 2005.
- (vii) HPSIDC would furnish a performance-cum-achievement report at the end of each financial year highlighting the number of units set up in the State, investment made and the employment generated etc., and the quantitative vis-a-vis qualitative outcome achieved out of Central Capital Investment Subsidy Scheme including suggestions/policy reform initiatives for further refinement of the Scheme.
- (viii) HPSIDC to ensure that amount is released to individual unit(s) only after verifying that these units have not been paid earlier.
- (ix) Payment to units should be made through Electronics Money Transfer directly to their account.


