1.	Can I start a Start-up firm or a private limited company on my name.	No information is available in this section. As the matter pertains to availability of name and incorporation process, application is being transferred under section 6(3) of RTI Act to CPIO, Ministry of Corporate Affairs.
2.	What is the procedure for opening a Startup firm for a PSU employee.	You may incorporate an entity as a Private Limited Company (as defined in the Companies Act, 2013), or a Registered Partnership Firm (registered under section 59 of the Partnership Act, 1932) or a Limited Liability Partnership (under the Limited Liability Partnership Act, 2002). To recognize your entity as a Startup, you may apply on the Startup India Portal (http://www.startupindia.gov.in) at the link http://www.startupindia.gov.in/startup-recognition.php . In respect of various PSU employees, conduct rules on the subject may be applicable, information regarding which is not available with this section.
3.	Can I own a Startup firm.	Yes, anybody who is having an innovative idea can start and own a Startup.
4.	Which post can I possess in a Startup.	In this regard, no such information is available with this public authority. Reply may be treated as NIL.
