I am directed to invite reference to this Department's notification dated 22nd January, 2013, on FSS and to this Department's letter no. 10(3)/2011-DBA-II/NER dated 12th October, 2011, on the above mentioned subject and to say that a number of representations have been received from Government of Himachal Pradesh stating thereby the difficulties being faced in fulfilling criteria laid down in Check list A and Check list B of TSS/ FSS. The matter has since been examined and the following amendments to the Checklists are being made:


S.No. as listed in Form-A of CTSS, 1971/ Annexure-III of FSS, 2013	Brief description	Amendment
7.	Income Tax Registration Certificate	The units may be allowed to submit copies of Income Tax Return which is a proof of payment of Income Tax.
8.	PAN card in the name of Unit	In case of proprietorship firm, PAN issued in the name of the proprietor may be accepted.
17.	Factory license No. & Date	In case of a unit where there are less than 10 employees and factory licence is not issue, requirement of production of such licence is waived off.
19.	NOC from Mines & Minerals Department; if applicable	Registration with Mines and Minerals Department as a 'dealer' may be accepted. Further, verification of raw material obtained by the Mining Officer may also be accepted.

8.	VAT clearance Certificate	Copies of Tax returns filed along with proof of payment of Sales Tax/ VAT as per return may be accepted in lieu of VAT Clearance Certificate.

DIC in lieu of employment certificate from D/o Labour, cannot be acceded to in view of the fact that in States like Meghalaya, Office of the Employment Officer, District Employment Exchange is issuing a certificate indicating the number of local employees and non-local employees.



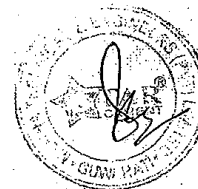
